

## Alumni Campground

We are a private campground under the auspices of Paul Smith's College. The Alumni Campground is open to all alumni, students, groups and individuals who are a part of the "Paul Smith's Community". Paul Smith's College is a not for profit facility, any funds collected go directly to the Alumni Campground to offset the operation and care of the site. All individuals and groups are asked to keep the facility neat and clean for the next person.

All persons entering the Alumni Campground must reserve a campsite with the Paul Smith's College Alumni Office at (518)327-6253 or <a href="mailto:camping@paulsmiths.edu">camping@paulsmiths.edu</a>. There is a \$15.00 per night charge for the lean-to sites and a \$8.00 per night charge for the tent and RV sites.

## When registering you be required to provide:

The total number of people in your party.

The number of nights you plan to stay.

The total number of vehicles, license plate number and make/model of each.

If you have a service animal or pet, you must provide proof of rabies vaccination on arrival. Please note that all animals must be confined or leashed at all times. It is your responsibility to clean up after your pet.

Failure to comply with these rules my result in removal from the campground and the revocation of all use privileges.

## Campground Rules

- 1. Users must sign a registration/waiver form at the Campus Safety Office on the Paul Smith's College Campus.
- 2. Users must show proper identification and leave a \$25.00 deposit to receive the gate key.
- 3. Maximum number of users on each site is 6. More than this will require an additional site.
- 4. Use of the facility is limited to 7 consecutive days.
- Day Use: Anyone not camping is a day-user
   Day use hours are from 9AM to 6 PM
   Day-users are not allowed in park between 6 PM and 9 AM.
- 6. THERE IS NO CAMPING WITHIN 100 FEET OF THE WATER (A.P.A. REGULATION).
- 7. All campers will occupy and place equipment only on assigned campsites.
- 8. Quiet time will be observed by users between 10 PM and 7 AM.
- 9. Parking in assigned areas only, no parking in/on roadways.
- 10. Driving to lean-tos for unloading/loading only.
- 11. Motor vehicles allowed only on designated roadways.
- 12. No trailer boats are allowed beyond the main parking area. Only kayaks, canoes and guide boats may be launched at the facility.
- 13. Motorized water vehicles will **NOT** be launched from any campground shoreline.
- 14. NO LITTERING. All trash and refuse will be dealt with on a carry it in, carry it out basis.
- 15. Fires are permitted only in designated fire rings and are **NOT** to be left unattended.
- 16. No standing trees or vegetation of any kind will be cut or damaged. Only downed, dead trees can be used for firewood.
- 17. No swimming allowed from any campground shoreline.
- 18. Fishing will be permitted in the campground during the appropriate seasons and with a valid New York State license.
- 19. No firearms are permitted. No hunting in campground.
- 20. Most importantly happy camping!
